
IN RE: 2012 Collective Bid Agreement with Greene County Engineer

WHEREAS, this cooperative Collective Bid Program affords significant savings to Sugarcreek Township through the economies of scale realized by group purchasing and unified contract administration,



WHEREAS, the Trustees desire to participate with the Engineer in the competitive bid contract for the **Collective Center Line/ Edge Line (County Doing the Work) 2012** as bid by the Greene County Engineer.





